### Long Range Plan:

• LRP Committee, (Vas, Melissa, Malia/Paul, Matt) to meet next week with NJB, the lead candidate to undertake the master plan for HVIA. The selection of design firm should be finalized soon.

• A vegetable garden was recently proposed for the east-end mini park. The Board decided to incorporate the idea into the master plan process, along with other potential park uses, to allow HPHA members to comment and ultimately select which park uses to include in the LRP.

Minutes of the March meeting were passed around for review.

<u>Financial</u>: Finances are generally good with homeowner is behind and will be sent the "first notice" payment letter.

<u>VIP Program:</u> The next step in Hydr's VIP program is to order stickers for the rear windows of cars belongue to park residents. Example stickers were displayed and Board members voiced heir opinions on the layout and color of the stickers. Final decision will be made by the VIP volunteers with advice from the manufacturer.

#### ACC:

• The City of Dallas Sode Inspectors distributed general code compliance information door hangers to the La Bolsa-side of HPHA. The Arapaho-side had the same information distributed two weeks prior.

• Policy reserving "boats, trailers, junk cars, storage pods, and dumpsters" – draft policy was discussed, general agreement however some changes suggested in wording. A revised policy statement to be sent out for further review.

• Acceptizing – The Board discussed the placards placed on fences by fence whether to allow placards for a limited amount of time after which the placards must be removed; or to allow placards of a certain size to remain on fences for an unspecified amount of time. No decision reached, to be further discussed.

• Motion passed - All new or replacement fences require ACC approval.
